- b. Sexual Harassment Training: Don objects to this training on an annual basis as there is nothing new presented; he agrees with the intent of the law, but not the actual implementation of training every year; he is refusing to do it
- c. Pandemic Operations Plan-NYS Law 27-c: Jessie explained that she and Sandy had watched a zoom presentation and gained ideas on producing a plan specific to our library
- d. Santa's Secret Shop Schedule: Wednesday-Don and Anita, Thursday-Pam, Saturday-Jess; Jessie will be there all 3 days

Changes to Agenda:

- a. Kim's mother had emergency heart surgery, is staying with Kim and is doing well; Jessie is filing PFL papers; no exact date for Kim's return but she could take up to 12 weeks; Donna will hopefully be cleared to work soon; Liz and Jessie have been filling in
- STLS advised libraries to make their own schedules for Christmas: Jessie advised closing from December 23-January1 and said that Kim suggested closing at 6 as there are very few patrons between 6&7
 - Don made a motion to close the library from December 23-January 1 and to close at 6 pm with the early closing being in effect until the April 19th meeting at which time the early closing would be addressed again, seconded by Barb; Jim was opposed to the early closing for a short period of time as changing hours is confusing for the patrons; Jessie suggested postponing the 2nd half of the motion and she will collect data on the 6-7 hour; Don asked to strike the motion and presented a new motion to close the library from December 23-January 1 Vote: Freda-Y, Jim-Y, Pam-Y, Barb-Y, Don-Y, Jess-Y, Sandy-Y, motion carried
- c. Roof Quote: will table this until pictures and quotes are in our hands; Jessie expressed concern that substantial snow may cause leakage and added expenses, Don agreed there is some risk but likelihood is small
- d. Reports on website: Don suggested more financial information on the web would make what we are doing with tax money more transparent to the public; Jim cautioned against putting out bank statements and other reports for security reasons; Jess would prefer the public to come into the library to see financial information; agreed-no financial information except what is in the minutes
